**LETTERS TO THE EDITOR****CHILD "PROTECTION" AGENCIES  
WAGE WAR ON FAMILIES**

**T**here is a silent "war on families" that is being waged by child protection agencies. Families are being devastated, children being taken from families on the most absurd charges (false and un-investigated reports of abuse, absurd charges like isolation due to homeschooling, or practicing alternative medicine, cluttered house, cuts or other wounds from normal child's play etc. and other things), and in most cases no matter how many hoops the parents jump through or programs they complete to satisfy the agency, they are unlikely to see their children again, let alone get them back.

In talking with families, there is an atmosphere of fear that we - meaning families - are living in. It is relatively easy for social workers to take children on the most absurd charges - they have the power to do so and they routinely lie, fabricate "evidence," violate laws, deny parents their rights and threaten families - as a matter of course. Sometimes they threaten the very children they are supposedly protecting. Most families make it real easy by simply cooperating, thinking since they didn't hurt their children, the truth will come out and they will get their children back. It rarely happens that way.

Children are raised in the foster care system, or adopted out, when they should never have been taken from their families in the first place, or could have been returned after all the demands on parents were met by them. Children are told by child protection workers that their families don't love them or want them as a way of breaking the familial bond. Most children live in 5 - 30 foster homes during the time they spend in foster care.

Most families are devastated after the child protection wrecking ball moves through the family - parents sometimes end up divorcing, suffer health problems, have high attorney bills, mortgage their house to pay legal bills, and many file for bankruptcy. Some consider suicide after losing their children.

You are probably accustomed to the usual headline-grabbers about abused children. But did you know the federal government and each state pays child protection agencies for children in the system? The longer the children stay in the system, the longer the agency gets money. And, social workers are the determinants of what is child abuse and what isn't. To add insult to injury, families are routinely billed thousands of dollars for the time their children were in foster care. Their assets are attached or wages garnished to pay the bill. So foster care agencies collect from the federal government, state government and the parents for destroying the lives of children.

## From the Chair:

We, as a Party, set two main internal goals this year:

1. Increase our dues-paying membership to 7,000
2. Increase our monthly pledge base to \$6,000 per month.

**Goal 1:** The September LPC membership was 6097. Another December has arrived without achieving our goal of 7,000 dues paying members. In retrospect, the LPC probably shouldn't have set our goals so high. However, the reason for setting that goal hasn't changed. That is, if we're to change the course of the future,

either by replacing one of the older parties or simply joining their ranks, it's going to require a much larger organization than we have today. So, job one has to be membership growth.

**Goal 2:** The October monthly pledge base was \$5,432.15. This includes funds passed through to the local regions. The latest numbers show 242 individuals pledging \$5,518.31 per month. We're getting very close to our goal of \$6,000 per month. While you're in the holiday gift-giving frenzy, please consider a modest investment in your future and the future of your country.

Thanks to 305 candidacies, a lot of volunteers, lots of money, professional paid staff, some good ideas, and a little luck, we managed to elect 14 libertarians to local office this year. We haven't figured out all of the answers, but we do know how to win. The key to our future is to continue to demonstrate that we can repeat these successes. I am confident that a track record of wins will make our progress easier, although by no means easy.

As I do every month, in one form or another, I ask you how fast do you want us to succeed? We may not be a well-oiled machine or as precise as a Swiss watch, but we do know how to get the job done. How fast we get the job done is a matter of the resources at hand. Those resources come voluntarily from you.

Even though today we have a full time Executive Director, part time assistant, two part time contractors, an office, a budget of \$305,000, 6,052 dues paying members, 94,538 registered libertarians, and media coverage over 1,600 times so far this year, it's not enough.







### NO BREAK EVEN AS ELECTION ENDS

**E**lection Night and the days following were hectic for LPC Executive Director Juan Ros —but extremely rewarding, given the outcome.

“On Tuesday night [Election Night] I stayed in the office until about 1:30 in the morning,” Ros said, “not only because I was watching the dramatic turns the presidential election was taking, but also because we had so many candidates for which to keep checking results!”

Around midnight Ros received a call from AdrenalineRadio.com and was interviewed on the air for about 15 minutes, commenting on the election.

When Ros returned to the LPC office in the morning he was pleased to see that seven Libertarians had won their races. He immediately issued a news release touting the wins, as well as the fact that Harry Browne outpolled Pat Buchanan in California.

Ros also issued a news release praising the passage of Proposition 36, which will divert nonviolent drug offenders to treatment instead of prison. The Libertarian Party of California had endorsed Prop. 36.

“It’s important to keep reminding voters that the failed War on Drugs continues,” Ros noted. “When there is a set-back in this insane war (such as Prop. 36), it behooves Libertarians to praise it.”

But even though November 7 has come and gone, Ros is not taking any breaks — he’s looking ahead and planning for the next few years of the LPC.

“Now is the time for Libertarians to regroup, assess our successes and mistakes, and begin planning and preparing for the future,” Ros said.

Among Ros’s plans for 2001:

- An expanded version of Operation Breakthrough, the LPC’s successful candidate recruitment program. “It depends on how many counties are holding special district elections in 2001; that’s what will determine whether or not we’ll do a full recruitment effort or hold off until 2002. But whatever is decided, we will continue our focus on running as many non-partisan local candidates as possible, and making sure those candidates have the support they need to run strong campaigns — and hopefully win!”
- An aggressive membership growth program. “I think we can take what we learned with Operation Breakthrough and use a similar procedure to sell membership,” Ros said. Although such a plan would require the approval of the state executive committee and the appropriation of necessary funds, Ros thinks the effort would be worth it. “If we used a professional telemarketing company to call as many registered Libertarians as we can afford to, I think we can convert a substantial percentage of those registered Libertarians into dues-paying members,” Ros explained, “and perhaps reach as many as 10,000 members in California!”
- Continued media outreach, including Spanish translations of all news releases. “With (Administrative Assistant) Alex on

board, we have the resources to quickly translate each release into Spanish. Hopefully we can make some inroads with Spanish-language media in advance of 2002,” Ros said.

- Activating official Libertarian Party local organizations in all 58 counties. At present only one county — Kings — does not have an LP contact, and a handful of other counties are in the early stages of organizing. “By 2002 we should have LP organizations everywhere in California so that voters can find us no matter where they live,” Ros pointed out.

**“2001 is going to be a year of continued building for the LPC,” Ros concluded. “We have made tremendous progress these last few years — California Libertarians should be very proud and very hopeful of what the future holds!”**

# ELECTION RESULTS

## Browne outpolls Buchanan in California, Three Races Very Close SEVEN LIBERTARIANS ELECTED TO OFFICE!

Seven Libertarians have been elected to non-partisan office in California, while presidential candidate Harry Browne has outpolled Patrick Buchanan despite Buchanan spending considerable money on radio and TV ads in the Golden State.

The seven wins by Libertarians brings to 14 the number of California Libertarians elected or re-elected in 2000, including one win in the primary and six other Libertarians whose non-partisan elections were uncontested. **An estimated 51 Libertarians now hold elected or appointed office in California.**

“We are very pleased with our results and are proud of all 305 Libertarians who appeared on the California ballot this year,” declared Libertarian state chair Mark Hinkle. “We ran more candidates than all other third parties combined, our candidates got the message out, and we worked hard to make sure voters knew that only the Libertarian Party will fight to dramatically reduce the power and presence of government in their lives.”

The seven Libertarians elected to office are:

- In Kern County, **Teri Kahn** was elected to a two-year term as Director of the Tehachapi Valley Health Care District with 55.5% of the vote
- In Placer County, **Erik Henrikson** defeated fellow Libertarian Tom Murphy in a two-way race, replacing retiring Libertarian Dennis Schlumpf to become the next director of Seat 4 of the Tahoe City Public Utility District
- In Sacramento County, **Joseph Corey** swept past incumbent E. Ramona H. Krewson to win one of three director seats on the Galt Fire Protection District
- Also in Sacramento County, **Michael McFarland** won a seat on the Fulton-El Camino Recreation and Park District
- In San Diego County, **Linda Strom** won one of eight positions on the Lakeside Community Planning Area board, while **Robert R. Mendez** beat incumbent Richard L. Vasquez in Division 2 of the Vista Irrigation District
- In Santa Barbara County, **Greg D. Flores** surprised his better-known opponents to win the Division 1 seat of the Santa Maria Water Conservation District.

Also in California, Libertarian Party presidential candidate **Harry Browne** received 44,272 votes to Reform Party candidate Pat Buchanan’s 43,751.

At press time three other races with Libertarian candidates were extremely close — all with margins of less than 45 votes — with several hundred thousand absentee ballots remaining to be counted statewide. County elections officials have until December 5 to count any remaining ballots and certify the results.

- In the closest race, Libertarian **Kate O’Brien** has pulled to within fourteen votes of her nearest opponent in the hotly contested race for three director positions on the Rancho Simi Recreation and Park District in Ventura County. O’Brien has received 16,610 votes to opponent Jim Dantona’s 16,624 as of November 15.
- In Contra Costa County, Libertarian **Barbara Kowall** needs 36 votes to catch up to her nearest opponent in the Rodeo Sanitary District race.
- In Orange County, Libertarian **Neal Franks** is 43 votes away from his nearest opponent in the Sunset Beach Sanitary District race.

In another race, Libertarian **Donald Osberg** was edged out in a hard-fought race for the Upland City Council in San Bernardino County. Osberg — who spent over \$30,000 of his own money on the campaign and was assisted by Libertarian campaign manager/Executive Committee representative Aaron Starr, LPC Secretary Sandi Webb, and others — came in second in a field of five candidates. He received 30.8% of the vote, to winner Kenneth Willis’s 33.4%.

“Libertarians have reason to celebrate this year. We expect the Libertarian Party to continue growing, and we plan to compete in and win more races in coming years,” Hinkle concluded.

## US ELECTION STATISTICS

Nationwide, more than three million people voted for a Libertarian candidate. More than one million voted for a Libertarian for U.S. Senate, and about 1.7 million voted for a Libertarian for U.S. House.

### POLITICS AS USUAL

#### Afternoon Sports Banned in Afghanistan

Afghanistan's ruling Taliban Islamic movement ordered a ban on all sports played in late afternoon and early evening because they could disturb Muslim prayers, the official Taliban radio said.

#### No Rude Gestures to Traffic Cameras

German motorists have been told to stop making rude gestures at traffic cameras or they could be charged with offending the police. A Bavarian court has ruled that a driver who held up his middle finger while passing a traffic camera was addressing police officers rather than the equipment itself. Germany is renowned for having no speed restrictions on many of its motorways but rigorously enforces limits on other roads, often with the help of speed monitoring equipment.

#### Tweety Bird Violates Weapons Policy

A sixth grader was suspended for possession of a Tweety Bird wallet that violated a school weapons policy. Ashley Smith, an 11-year-old girl in Atlanta, Georgia, was suspended for two weeks after school officials noticed her wallet, which bore an image of the yellow bird-like cartoon character, was attached to a 10-inch key chain. The county school district has banned chains as part of a zero-tolerance weapons policy that places the items in the same category as pellet guns, ice picks and swords.

The Earned Income Tax Credit program for the working poor lost \$7.8 billion because of fraud and errors in 1997 — one-quarter of the claims made that year, the Treasury Department reported.

Alberto Sepulveda was an 11-year-old who was shot and killed by a SWAT team member during an early morning drug raid on his parents' Modesto home in September. The killing highlights a troubling trend in law enforcement: stealth raids on the homes of sleeping citizens by heavily-armed government agents.

#### Live And Let Live Sentiment Thrives In Denmark!

Central Copenhagen's hippie colony, Christiania, intends to cling firmly to its own local currency regardless of the outcome of Denmark's referendum on joining the euro. Christiania, a 30-hectare, former military compound bordering a picturesque moated area in downtown Copenhagen, was occupied by hippie squatters in 1971 and declared an autonomous "free city" and alternative society. After years of debate, the Danish government finally dropped threats to repossess the area. The loen (meaning pay) was introduced in 1998 backed by financial guarantees from foreign banks. Although meant solely for internal use inside the territory, the currency generates profits from sales to tourists. The loen coin, featuring a snail on one side to reflect the pace of life at the colony and a woman's head on the other, bears the motto "Live and let live." One of the most popular tourist attractions in the capital, Christiania, with its population of about 1,000, is visited by some 500,000 people a year — many coming to buy marijuana on the infamous "Pusher Street."


The shocking truth is that none of the drug warriors we've encountered have ever been challenged in court. These "experts" have been exposed and will never be so effective again.
