The adopted text of ballot **PC2020-PC#15** is now appended to 2.13, the current text reads:

2.13 Health Care

We favor a free market health care system. We recognize the freedom of individuals to determine the level of health insurance they want (if any), the level of health care they want, the care providers they want, the medicines and treatments they will use and all other aspects of their medical care, including end-of-life decisions. People should be free to purchase health insurance across state lines. We oppose the government mandating or denying treatments or vaccines.

NEW PLANK – TITLE TBD – suggested title is Medical Freedom-PLACEMENT TBD- suggested to be placed after Self-Defense

Problem: The state already mandates vaccines to use services it force-funds. That is tantamount to mandatory vaccines in order to exercise the privileges everyone has. In the age of COVID-19, we can expect to see this reach further. It also addresses the issues involved in "Medicare for All" or any similar scheme in that the state will inevitably deny services to some and be the arbiter of life and death. We saw this with baby Alfie Evans in England with the NHS.

Solution: A short simple statement addressing medical freedom when it comes to the state.
