Council District Two


The seat being vacated by Doig in District #2 is being contested by Tony Souza, Tom MacMichael, Tom Marsella and Joni Johnson. The leading contenders are Souza and MacMichael. Souza has good grassroots organizational support and MacMichael has a bank full of money. This will turn out to be a rather classic case of the organizational campaign against the media "image" campaign.

MacMichael seems to be the annointed candidate of the large developers since he served on the City Planning Commission for several years and piled up chits for several key votes on zoning. In any event, his contribution list reads like a "Who's Who" of the development community. MacMichael should spend at least \$40,000 in the campaign, double that of Souza.

One of the many areas of disagreement between Souza and MacMichael is over Far West Airlines. MacMichael supports the city involvement in Far West. Souza takes the position that it is the job of the city to provide a good climate for private investment—not to become the business owner.

Tom Marsella's main campaign thrust has to do with "unchaining" the school grounds so that kids can use the

Kidnapping Truants

Court Ends Open Season on Kids

A December decision by a Santa Ana appeals court has effectively ended the joint "street sweeping" effort of the Fresno Police Department and Fresno Unified School District known as Operation Stay In School. For several years the police department, in cooperation with the school district, had used a misinterpretation of the California Education Code as an excuse to accost and take into custody any person who appeared to be under the age of eighteen and who was on the streets of Fresno during FUSD school hours, for "suspected truancy." The Fresno Bee report of the court ruling and subsequent suspension of OSIS states that California Education Code authorizes attendance supervisors or peace officers to "arrest or assume temporary custody of a minor suspected of being truant." The actual

language of the code in question authorizes attendance supervisors or peace officers to take into custody minors "found away from home and absent from school without valid excuse." The court has ruled that language to mean only actual truants may be taken into custody, not merely any youngster an officer might suspect is truant.

Program in Practice

The OSIS program in practice, was not the "extremely successful" antitruancy program it has been called by various FUSD and FPD officials. The drop-out rate in FUSD schools actually increased after OSIS began, and nearly every California high school drop-out under the age of 18 is

Council District Six

District #6 is up for grabs. This is the seat being vacated by Joe Williams who chose not to re-run. The main contenders are Rod Anaforian and Larry Powell followed by Bob Myers and Jay Steinman. Anaforian seems to have a professional, well financed campaign and Larry Powell has put together a good organizational effort. Steinman ran against Williams four years ago and should have some name identification. Myers is a coach at Roosevelt High School and has some community support. Should be a runoff situation to be decided in May.

Teen Suicides Explained

Clinical psychologist Pamela Cantor, president-elect of the American Association of Suicidology, has offered the following explanation for a 136% increase in the rate of teen suicides between 1960 and 1980. "The rise in teen-age suicide primarily is in the West. That may be because the Western states are expanding; there is isolation. In the West, there is too much space, and there are not enough people."

Cantor has suggested mandatory mental health classes for teens to solve the problem. (An alternative theory is that teens are driven to suicide by swarms of muddle-minded "experts" who insist on invading and managing their lives.)

Geologists have reported no significant "expansion" of the Western states since 1960 that would account for Ms. Cantor's perceived isolation among residents. Census bureau statistics indicate that since 1960, the Western states have enjoyed substantially more people and less space in which to fit them. It has been suggested that the current "experts" on the subject of suicide are more in need of mandatory mental health classes than teenagers, and that requiring sanity certifications of clinical psychologists might be the key to reducing the teen suicide rate.







legally truant. Neither agency has produced any documented evidence that OSIS increased school attendance in FUSD schools or cut the rate of daytime burglaries in Fresno, although they made both claims. Hundreds of students, instead of being encouraged to go to school by OSIS, were actually kept out of school by the program, since they were taken into custody on their way to school, and never got where they intended to go.

A section of the California Education Code immediately following the section FUSD and FPD used to justify the OSIS program requires that any person assuming custody of a truant minor must "forthwith deliver" that minor to either his parents or his assigned school. Neither FUSD nor FPD complied with that section, which was intended to protect the youngsters taken into custody. FPD officers delivered the youngsters to FUSD "centers" where they were held until a parent could be found to provide transportation. If no parent was contacted, the children were merely ushered out the door of the centers and left, often miles from their homes or schools. Thus, children taken into custody by police officers were often left wandering around the city, with no responsible adult knowing where they were or why they were where they were. That this situation endangered the youngsters who got caught up in OSIS was ignored by both FPD and FUSD officials.

Difficult to Swallow

It is a bit difficult to swallow FPD's contention that OSIS cut the number of daytime burglaries by 25% to 60%. The program normally operated only between the hours of 8:30 and 11:30 a.m. FPD acknowledges that most daytime burglaries take place in the afternoon. If one assumes that OSIS actually did cut the burglary rate by keeping the burglars in school, one must then question the wisdom of using FUSD schools as a holding tank for individuals who have no qualms about thievery, and the effects on education of having such individuals roaming campuses and sharing classrooms with serious students.

Finally, the OSIS program was questionable on serious constitutional grounds, for it created a suspect classification of individuals (persons who appeared to be under the age of 18) who police were instructed to assume were guilty of wrongdoing until and unless they could be proved innocent. The basic assumption was that any kid not in an FUSD school during FUSD school hours was a criminal, and to be treated as such. OSIS was nothing more or less than an excuse for FPD to declare "open season" on kids.

Sickening Example

In the last analysis, Operation Stay in School was a sickening example of two public agencies cooperating (or conspiring) to dump their responsibilities on one another. The police department used public schools as crime prevention and detention centers, while the school district used the police department and children's fear of being taken into custody to try to keep students in its schools. FUSD administrator William Booth, bemoaning the end of OSIS, says the court decision which resulted in the suspension of the program "makes our lives more complicated." He has acknowledged that providing schools in which students want to stay is a bigger "complication" than FUSD administrators feel willing or able to deal with.

The final irony in the case of "Operation Stay In School" came from Dr. Booth, who informed the public that FUSD "attendance officers" would now be picking up youngsters suspected of being truant. That statement is utterly false, and to any parent or child who believes it, extremely dangerous. FUSD has left the impression that people calling themselves truant officers will be wandering about the city with a legitimate reason to pick up children. We can only hope that the Play It Safe organization has been so successful in educating the children of our community about their personal safety that any FUSD employee who tried to "pick up" any child in Fresno would be immediately set upon by outraged citizens who would confine him in a now redundant OSIS "reception center."
