DON'T Save Lives, **British Govt. Reports**

Compulsory use of seat belts does not save lives, according to a startling British government report - and one expert says it's because belted drivers are more reckless and cause more accidents.

The report, prepared by the British Department of Transport, says mandatory seat belt laws passed in eight European countries between 1973 and 1976 have "not led to a detectable

change in road death rates.' In fact, preliminary figures from rates in those countries actually jumped 11 percent.

strongly that seat belt legislation has failed," declared Dr. John Adama, a transportation expert with London's University College, who studied the effects of seat belt laws.

Compulsory seat belt laws went 1963 - and 11 months later the number of bicyclists killed by cars or trucks was up 19 percent, and the sumber of pedestrians killed jumped 6 percent, according to the government.

In Sweden, two years after a sest belt law was passed, the total number ef car occupants killed in accidents rose 6 percent.

Similarly, the traffic death toll rose in Denmark, Ireland and Belgium after mandatory seat belt laws, were put into effect, Adams said.

"When safety records of countries that have seat belt laws are compared with those that do not have them, there is no firm basis for comcluding that seat belt legislation has saved any lives or reduced acci-dents, he said.

Mandatory seat belt laws may actually result in more accidents, he added because 'once a driver has a seat belt on he feels more secure and is encouraged to take more risks."

Another traffic safety expert, Mick Hamer, transport consultant for England's science magazine New Scientist, added: The evidence indicates that compulsory seat belt laws actually increase death and injury to pedestrians and bicyclists."

Only two states, Massachusetts and Nebraska, have experienced highway safety statistics both with a mandatory seat belt law and after their 1986 repeals. (Oregon voters in 1988 defeated their law.) In a recent report of the National Safety Council, both states showed a marked increase in highway fatalities under a mandatory seat belt law (forty-two in Massachusetts in 1986), and a sharp decrease upon repeal (forty-two in Massachusetts in 1987). Massachusetts showed a 10 percent, and Nebraska a 12 percent, overall decrease in highway fatlities since repeal of their respective laws. Apparently other factors, such as "risk compensation", often come into play when such legislation is imposed. In other states which have imposed mandatory seat belt laws, an increase in highway fatalities has been a result. (i.e., 1987-88 in Iowa by 18 percent, in the District of Columbia by 21 percent, and in Connecticut by 22 percent.)

The assertion that mandatory seat belt laws provide increased injury protection also has come under suspicion by the Highway Loss Data Institute. 

Taxpayers should demand politicians who are frugal-minded

Everyone is fed up with rising property taxes. Nobody doubts that property owners need relief. South Carolina has one of the highest total tax burdens of any state in the South. Figures published in U.S. News and World Report show that Atlanta is the only city in the Southeast with a higher tax burden than Columbia.

South Carolinians would obviously benefit from lower property taxes. However, politicians often take a good idea and turn it into bad legislation. The local option sales tax is a good example, and so are efforts to give counties the power to tax motor vehicles. The local option sales tax bill (often called the Local Government Finance Act) would allow local governments to impose a sales tax, using part of the extra tax money to roll back property taxes a little bit.

If cities and counties are allowed to impose sales taxes on their citizens, the economy of the state will suffer. Property taxes are deductible on federal income tax forms, but sales taxes are not deductible. Therefore, if any property tax revenues are replaced by sales tax revenues, South Carolinians will be forced to pay more in federal income taxes. This will leave less money in South Carolina and more money in Washington. Does anybody seriously believe that this would help South Carolina?

The Libertarian Party is fighting for the tax: payers and against higher local taxes, and is opposing the local sales tax for the fourth straight find it more difficult to offer new jobs. This will good men to do nothing." reduce our standard of living and increase the unemployment rate. Higher sales taxes will be especially harmful to the poor and the elderly.

According to a recent poll in The State, 51 percent of South Carolinians are against higher sales taxes, but 73 percent would favor a local option sales tax "if it means your property taxes would be lowered." This wording is deceptive, however, since no politician or government can make an unbreakable promise. Any property tax relief will be temporary, unless voters begin to elect persons who understand the value of frugality, privatization and free enterprise. No government has ever voluntarily lowered taxes without later raising them much higher.

Instead of raising taxes, governments should reduce spending by privatizing many of their ser vices. For years, Libertarians have pointed out that privatization can result in better services at less cost to the taxpayers. This has worked when it has been tried. However, most elected officials

Doc overpays IRS \$114G but he can't get it back!

A doctor overpaid his federal taxes by \$114,000 and a federal judge has ruled that the Internal Revenue Service doesn't have to give it back!

The mind-blowing tax goof occurred when IRS agents told Dr. Parvane Korangy of Potomac, Md., that he hadn't paid taxes on \$637,000 he had in the bank.

Dr. Korangy denied that the money was taxable and appealed to a U.S. Tax Court. He later agreed to pay taxes on \$544,000 of the total and the court accepted.

Then, to his horror, the doctor discovered that he and his lawyer had made a math error that resulted in a tax overpayment of \$114,000.

IRS SENDS INMATE \$359,000

ATLANTA—A federal grand jury has indicted a federal prison in-MUSEUM mate who was mistakenly sent \$359,380.25 by the Internal Revenue Service and failed to return the money.

The IRS was attempting to collect \$2 million in back taxes in 1985 from Joseph H. Hale, who was serving an unrelated five-year prison term for fraud. But the IRS made a computer error and a check was mailed for \$359,380.25.

The indictment, returned Wednesday by a federal grand jury in Atlanta, charged Hale, 45, and a friend, Ann W. McRee, 43, of Atlanta, with seven counts of fraud. The indictment alleges that Ms. McRee helped Hale dispose of the money. They face maximum terms of 65 years.

After two years of searching, the IRS said it fcound \$55,558.34 of its money and wants the other \$303,821.91 back.

THE TIME HAS COME, THE WALRUS SAID, TO SPEAK OF MANY THINGS

One thing that annoys me is the use of words to say something different from what the word means. Fanatics of all sorts are addicted to this. Let us start with an ancient term, Aryan, and go to the dictionary and see what it means. Adolf Schickelgruber didn't know how to use the dictionary, because the group that received the highest death-rate in Nazi Germany was an Aryan group, the gypsies. Non-Aryan groups like the Finns, Hungarians (Magyars), Basques, etc. were not persecuted racistly, because he didn't know what an Aryan was.

Aryan comes from the old Indo-European, such as Sanskrit in India which was the first version written, meaning tribal leader or tribe. Of the languages that are a descendent of the basic Indo-European are most of the European languages (except those above), Persian, and some 6 or 7 in India, including Romany (gypsy). In Germany, the main non-Aryan language was Wend, a group that Hitler drafted into the German army because public schools had forced them to learn German. At that time the almost totally Aryan country was Iran, which is why the Shah called himself "King of the Aryans"; since then they have imported Semites (mostly Arab) as oil-fielders.

Not all whites are Aryans, which is based on the ancestral language. There are also Altaic (like Turk or Jewish Kazak), Semitic (like Arabic or Hebrew), and a few that just don't fit. If you're interested, the language closest to the original Indo-European in Lithuanian. The scholars who went into ancient language and found that words like mater in Latin, and Mutter in German and madre in Spanish and mother in English all came from the same ancient source; the ones you might have heard of were the Grimm.

Now let us proceed to the word Nazi. It is an abbreviation or nickname for a policial party with a very long name: National sozialistische Deutsche Arbeiter-partei, translated: National-Socialist German Workers Party. This is what a national socialist is. They borrowed a lot from Lenin, where they differed as he did with the Social Democrats (or Mensheviks in Russian), being for socialism, & against democracy. Then Hitler borrowed one thing from Stalin himself, his anti-Semitism (or maybe it was viceversa).

It is just like there are many whose language is one of the Aryan languages, who are not of white descent. Spanish has probably a majority of these.

The Jews of Ethiopia or China are pretty obviously not of Hebrew descent.

Curiously, the one country that never expelled the Jews (except some that never have had any until recently) was Scotland. It is amazing that Jews of Hebrew descent get along quite well with Christians of Celt descent, but Dublin elected a Jewish mayor once, and the Jews came out 100% for the Confederacy if they lived in it, and the first Jews to make the rank of colonel or senator or governor or cabinet member were in the Old South.



ASK YOUR CPA TAXPAYER BILL OF **RIGHTS**

By Raymond Mueller

On November 10, 1988, President Reagan signed the Technical and Miscellaneous Revenue Act (TAMRA) of 1988. It is the sixth major piece of tax legislation since 1981, but more specifically it sets forth what is called the Taxpayer Bill of Rights. The IRS has traditionally given taxpayers certain notice, explanation and other rights on an informal basis. TAMRA enacts these and various other rights as follows:

Disclosure Rights...

The IRS will provide taxpayers with a written statement of their rights and of the IRS's obligations. The IRS will try to prevent multiple notices being sent to taxpayers.

Taxpayer Interviews...

a) Reasonable place and time: Examination should be at the IRS office closest to taxpayer. IRS exams at taxpayer's business will be restricted if business is so small that an examination essentially closes the business.

b) Recordings: The taxpayer or the IRS may record interviews using audio equipment only. c) IRS explanations: The IRS will explain audit and collection processes and will inform the taxpayer of referrals to the Criminal Investigation Division

d) Taxpayer representatives: The taxpayer has a right to use a representative and can suspend an interview to consult with the representative.

Reliance on IRS Advice...

The IRS will abate tax and penalties related to incorrect IRS advice written in response to taxpayer's written request.

Taxpayer Assistance Order (T.A.O.)...

The taxpayer ombudsman (middleman) can issue a T.A.O. to help a taxpayer who is suffering or is about to suffer significant hardship due to IRS administration of the tax laws

IRS Employee Evaluations...

Quotas and similar production goals can not be used to evaluate IRS employees involved in collection activities.

IRS Regulations..

Temporary regulations will also be issued in

proposed form: temporary regulations can only remain in effect for three years.

Content of Notices.

Most tax due notices or deficiency notices mailed after 1989 must describe the basis for any amounts owed and will separately identify tax interest and penalty amounts.

Installment Payments...

The IRS is officially authorized to allow taxpayers to pay taxes on an installment basis if it will facilitate collection. The IRS generally must abide by such an agreement unless the taxpayer is in noncompliance or the taxpayer's financial condition significantly changes.

IRS Assistant Commissioner...

The position of assistant commissioner for taxpayer services is officially established within the IRS to handle items such as telephone, walk-in, educational and form design.

Levy and Distraint...

a) Notice: Thirty days written notice (now 10 days) will be given to a taxpayer before the IRS collects a tax by levy. The notice will be brief and nontechnical.

b) Property Subject to Levy: Certain definitions and amounts of property exempt from levy have been expanded

c) Levy on Wages: The amount of wages exempt

from levy has been raised.

d) Release of Levy: The IRS is now required to release a levy if the tax liability has been satisfied and in other situations.

11. Review of Jeopardy Levies...

New rules are provided for administrative and judicial review of jeopardy levies.

Administrative Appeal of Liens...

Taxpayers will have a procedure to administratively appeal IRS decisions regarding liens. The IRS will expeditiously issue a certificate of release if it is determined that a notice lien was issued erroneously.

13. Awarding Costs and Fees...

a) Recoverable costs: Taxpayers can now recover certain reasonable administrative costs (in addition to litigation costs) if the IRS takes a position that is substantially unjustified.

b) IRS position: The IRS position in any case is determined as of the date the taxpayer receives notice of the IRS appeals office decision or the notice of deficiency, if earlier.

c) Administrative settlement: The IRS now has

14. Damages for Failure to Release Lien... Taxpayers can sue the IRS in federal district court for direct, economic damages (plus costs) resulting from an IRS employee knowingly or negligently failing to release a lien as required under the law

Damages for IRS Unauthorized Actions. Taxpayers can sue the IRS in federal district court for direct, economic damages (plus costs) resulting from an IRS employee intentionally and recklessly disregarding the code or regulations in connection with the collection of tax. The maximum recoverable amount is \$100,000. Frivolous actions taken by taxpayers in this

area are subject to penalty. 16. Penalties for Preparer's Improper Action... Tax return preparers are now subject to civil penalties (in addition to criminal penalties) for improper use or disclosure of information obtained in connection with an income tax return.

Tax Court Jurisdiction...

The Tax Court has been given jurisdiction to do the following:

a) Stop the assessment and collection of any tax while a Tax Court petition is pending

b) Order the IRS to pay refunds in cases decided by the Tax Court.

ci Review certain IRS determinations to sell seized property.

d) Review a taxpayer appeal regarding an IRS calculation of interest on tax due following a Tax Court decision.

e) Modify a decision in an estate tax case to reflect interest expense deductions taken after the estate has been closed.





There has been much discussion recently about building a new highway from Florence to Myrtle Beach. Someone wrote recently suggesting widening the current highways (U.S. 301 to Marion and U.S. 501 to Conway). I have an even better suggestion.

My suggestion is so simple that I'm wondering why the engineers By Calvin Knox at the highway department haven't thought of it. But then, considering the mess they made of "Malfunc-tion Junction" in Columbia, it doesn't surprise me.

My suggestion is to pave the grass median between the already existing lanes, with a concrete bar-rier dividing the opposing lanes. This is what is presently being done to I-20 just north of Columbia.

IRS agent gets on Pres. Bush's case

President George Bush has already got himself on the bad side of the Internal Revenue Service. Bush apparently ruffled few feathers among tax collectors with his anti-tax, anti-IRS rhetoric during last year's presidential campaign.

His rhetoric moved an Augusta, Ma., IRS employee to write letters to editors bashing Bush and to also reveal a tax deficiency payment Bush made four years ago. The agent is now under investigation by his superiors for allegedly disclosing the confidential information about Bush's income tax history.

John Kozos, a 13-year veteran with the IRS, wrote a letter to the editors of two Maine newspapers blasting Bush's derogatory remarks about the IRS during the 1988 presidential campaign. "I resent Bush's notion that IRS employees work against the interests of the American public,' Kozos wrote late last October to The Lewiston Daily Sun and the Kennebec Journal. "Perhaps his attack is prompted by the fact that

in 1984, he was forced to pay \$196,000 in delinquent taxes, and he proclaimed then that he was going to challenge the IRS. Is this his challenge?"

Kozos is also a local official for the National Treasury Employees Union and signed his letter to the editors as such. But just weeks after the letters were published, the IRS began investigating Kozos for investigating Kozos for unauthorized disclosure of a taxpayer's personal tax information. The union has since tried to justify Kozos' letter, saying the information he referred to had been previously published in local newspapers and, therefore, was no longer confidential.

Kozos and other IRS agents apparently took offense at remarks during the campaign by Bush in response to Michael Dukakis' commitment to raise taxes and to arm the IRS with more tax collection power.

Bush took political advantage of the tax revolt sentiment throughout the country and bashed Dukakis for threatening to increase IRS power and abuse already oppressing the U.S. taxpayers.

IRS Loses Millions of Tax Documents Every Year

The Internal Revenue Service loses about two million tax returns or related documents from its files each year, according to an in-house study.

The agency usually discovers the loss when its employees, seeking to conduct an audit, make requests for tax return or related documents.

"It is very embarrassing to tell a taxpayer I am disallowing all of your losses and then ask them to provide a copy of their return because we can't find their original return," said one IRS employee quoted in the agency-wide study.

An IRS spokesman declined to comment on the study, saying it is raw material and not a finished document.

The report charts a path strewn with misplaced files, unnumbered tax returns, poor storage facilities, high staff turnover, costly delays and unnecessary duplications.

The study does not estimate how much tax revenue is lost each year because of misplaced original tax

'assault' weapons must go

In spite of a headline (written by The State, not the author) that seems to distort the true tone of his letter, Mr. Phillip F. Laverne (Letters, June 2) is absolutely correct in his observation that laws placing restrictions on honest citizens when purchasing firearms will not reduce crime, and that computers can be helpful in many areas of modern life.

However, his letter does not address the question of so-called "assault" weapons. While the topic of "assault" rifles has been covered fully in The State and elsewhere, I would like to address the issue of other "assault" weapons, such as:

- (1) "Assault" knives. Since those who would eliminate "assault" rifles tite appearance, potential for harm or lack of legitimate sporting utility. certainly knives which meet the above criteria should be banned as well; pocket, kitchen and fishing knives would be exempt; I am not certain whether electric carving knives should be allowed.
- (2) "Assault" sticks. Sticks having a legitimate sporting purpose (such as cricket bats and hockey sticks) would be free of restriction provided they are properly registered; walking canes would be allowed with a medi-cal prescription. Plain old tree limbs should be examined by a legislative committee (at taxpayer expense, of course) to decide whether they are legitimate sporting instruments.

(3) "Assault" automobiles. These same legislators should ascertain the type of vehicle most often correlated with fatalities and outlaw these autos (but "legitimate sporting uses" may be allowed).

(4) "Assault" people. In light of the recent rape and near-fatal beating of a young woman in New York City by feral beings (such perpetrators cannot be called human), I suggest that the logic of prohibition be carried to a final conclusion and include elimination (preferably by decapitation) of those possessed of the potential for

Legalizing drugs a way out of crisis

They are driving up the robbery and burglary rates, destroying neighborhoods, corrupting our officials, enticing our children into crime, and killing us at the rate of some 8,000 a year — and we haven't the will to get rid of them.

Make that the answer on the TV quiz show "Jeopardy!" and most of us would respond: "What are illegal 'drugs?"

And if James Ostrowski were the "Jeopardy!" host, many of us would go home broke. The right response, he would insist, is: "What are the laws against illegal drugs?'

Ostrowski, author of a new study from the libertarian Washington-based Cato Institute, argues that few of the drug-related problems that have produced the current "drug crisis" are the result of drug use. Virtually all of them, he says, stem from the black market spawned by our attempts to pro-

hibit drugs. "Since the black market in illegal drugs is the source of most drug-related problems," says Ostrowski, "that market must be eliminated to the greatest extent possible. The most efficient means of doing so is legalization.... The day after legalization went into effect, the streets of America would be safer. One year after prohibition was repealed, 1,600 innocent people who would otherwise have been dead at the hands of drug criminals would be alive."

The Ostrowski study, "Thinking about Drug Legalization," comprises some 60 pages of statistics. analysis, projections and well-reasoned argument. Is it persuasive? I doubt it. CAUCASIAN SELF-HATRED

By Otto Scott

Several years ago Susan Sontag, darling of the intellectual Left, said, "The white race is the cancer of

A few years later, after God struck Ms. Sontag with cancer, her views of the use of that illness as a pejorative changed. But her disdain for her own race may, for all we know today, remain the same. If so, she has

to escape descriptions of both historical and contemporary events without being told that it is all the fault of Caucasians — but not all Caucasians.

The slave traders of Islam are not psychoanalyzed or held aloft to scorn; the harem-masters of India and the evils of their caste system are barely recognized. The age-old indifference of the Orient to the value of individual life is seldom, if ever, the subject of indig-East are not eternally reviewed as evidences of religious fanaticism.

But Christian Caucasians are fair game. They are held uniquely responsible for the evils of the past. Their detractors are so numerous in contemporary Britain that The Spectator now refers to "the Race Industry" - in referring to professional monitors of behavior and association, whose livelihoods rely upon unearthing and prosecuting cases of discrimination and bias. Britain now has laws against openly prejudicial statements or actions - laws which might be beneficial if they were not applied only against

This pecularity in British justice has been explained to students as only fair, because Britain is dominated by Caucasians. And, it is argued, since Caucasians are responsible for the condition of the realm, only Caucasians should be prosecuted, fined and jailed for discrimination. All Britain's minorities, in other words, are victims by definition — and cannot be held guilty of violating the human rights of others, because whatever they do is done in reaction to a basically evil system.

This argument, which is echoed in American elite circles, in our courts and by our government, is not limited to the United Kingdom and the United States: it has swept the English-speaking world and its allies. It takes a variety of forms - almost all invidious and reeking with Caucasian self-hatred. For instance, there has long been a campaign against apartheid in South Africa which holds that such a system is the greatest evil in the world. Certainly it is not a good system. It is to be regretted that the Afrikaners and the English settlers in South Africa ever instituted or allowed such a system to develop. But we are now witnessing a progressive dismantling of that system and there is every reason to believe that it will fall of its own weight as the majority of South Africans rise in terms of education and living standards - and in

We say Christianity, because it is the only faith that accepts all men, of all races, from all geographical locations and from all walks of life - irrespective of lines of descent, language, color, culture and past behavior - as worthy of equal rights.



It was because of their faith that Caucasian Christians stopped the Amerindians of Centeral America from conducting their enormous human sacrifices, who ended the Hindu practise of forcing widows to sit in the midst of flames that consumed the cadavers of their husbands, who halted the slave practises of Black Africa, who lifted (though briefly) hideous despotisms in many parts of the Orient.

Even in the United States, where Christian Caucasians are subjected to seemingly endless sneers about It is difficult for adults and impossible for students their religion, their color, their forbears, their manners and appearance, their customs and rituals, hundreds of thousands of Caucasian Christians sacrificed their lives in a great Civil War to free black people from slavery.

Yet their descendants, and the descendants of other Christian Caucasians whose immigrant parents helped make this nation the most creative and altruistic so far seen on earth, are subjected to incessant nation meetings; the sectarian wars of the Middle charges that they are uniquely racist and unworthy of

> If such charges came only from non-Caucasians they could be more easily seen as prejudice. But the basic arguments were invented by Caucasians. And today we have many Christian Caucasians who pride themselves on loathing their own kind.

> These intellectual masochists decry the Christain Caucasians of South Africa, while tacitly approving the black government of Zaire, headed by Mobutu. Mobutu is now one of the richest men in the world, with a fortune estimated at \$7 billion. The condition, of the miners of Zaire is pathetic. Their wages are among the lowest; the dangers to which they are exposed among the highest. The people of Zaire are dirt-poor, and have little prospect of early improve-


> But neither our State Department nor our Christian Caucasian liberals are indignant over Zaire or Mobutu. They tacitly approve this horrid government because it is black. The blacks of South Africa may have the highest living standards of any black people in all black Africa - but they are governed by Christian Caucasians. And that is held to be unjust beyond

Without Christians there would be no chance for long-range survival of minorities in our midst.

Much the same can be said for the rest of black Africa, which is on the edge of a great tragedy. Disease, starvation, tyanny, urban and rural collapse, desertification — every definition of catastrophe applies to independent black Africa. Yet no films appear, no fashionable novels decry, no musicals are mounted, no boycotts launched — for all the evils are committed by non-Christian non-Caucasians — and it is only Christian Caucasians who can be safely made targets of indignation.

The atrocities of Cambodia; the wholesale murders in China; the wreckage of Lebanon and the renewed burning of brides in India do not, singly or in the aggregate, call for condemnation. The average Christian Caucasian does not, of course, believe such nonsense. Silence, in this instance, does not mean consent. But the elite, both Christian and non-Christian in the Caucasian-led societies of the West, appear adamant in pursuing the proposition that Caucasians are uniquely evil.

Things would come to a virtual halt if we couldn't trust each other, which is why breaches of trust must be taken seriously. Just think about it for a moment.

We pull in to a gas station, pump our 10 gallons of gas, and hand the attendant \$11; go into the supermarket and pay \$4 for a pound-and-a-half package of hamburger; put money into our account and accept the bank's word of our interest earnings. Many of us don't even bother to count our change. How do we actually know we, in fact, got 10 gallons of gas, or a pound-and-ahalf of hamburger, or earned \$22.11 on our savings? For the most part we don't; we trust people.

Imagine an economy without trust. All transactions would be more costly. We'd have to carry around measuring instruments. learn to make on-the-spot interest-rate calculations; in a word, monitor everything. Promises and gentlemen's agreements, which govern thousands of activities from returning merchandise to stock transactions, would have to be substituted by cash transactions and costly contracts.

In some institutions, such as the family, trust is the only glue. When I bring home money from teaching, royalties and lectures, my wife and I have this agreement whereby we toss the money in the air. All that stays up is mine; and all that comes down is hers. There's no effort to keep books and audit her spending. For all I know, she could have a secret Swiss bank account. Because of trust I don't have to undertake the costly job of monitoring inventories and auditing expenditures; we can spend the time we save by enjoying one another's company.

Whether it's family or emplover / employee relationships, we have to be able to count on people not shirking their duty. Again, trust plays a vital role because monitoring is costly. This factor may help explain why some ethnic groups, with strong cultural roots and intragroup trust, succeed under business conditions where others fail. Thanks to mutual trust, they avoid some business costs.

Trust relationships, taken for granted in the past, have been seriously eroded, and we're paying the price. Because of hustling lawyers and ignorant judges, doctors see their patients as potential plaintiffs. The cost: Doctors order diagnostic tests not with the view of helping their patients, but with a view of what they might say on the witness stand.


Businesses must limit themselves to very short planning horizons, thus restraining national growth, because they can't trust Congress and the courts. In other words, when you start a project with a 10year payoff period, you'd like to be able to count on stable tax and business laws. Take, for example, Congress' recent tinkering wherein it prohibited adults-only housing projects on the grounds that they discriminate against families with children. Here you've built a development for adults and, with a stroke of the congressional pen, the value of your investment is reduced.

And it's not just business that suffers from distrust. Years ago, preparation for retirement was no more complicated than simply opening a savings account. You could trust that a dollar 10 to 20 years later would have roughly the same purchasing power. Congress, aided by the Federal Reserve Bank, has virtually destroyed long-term trust in our currency. As a result, preparation for retirement or for our children's needs is a riskier, more complicated proposition today.

Congress, through the Internal Revenue Service, requires taxpayers be notified in the case of underpayments, but IRS agents, under the threat of losing their jobs are not to notify taxpayers of overpayments IRS just keeps the money. That's a great boost for taxpayer trust, honesty, and confidence

Once lost, trust, like virginity, cannot be regained. But all these attacks on trust can be halted. Let's do it.

SOME REFLECTIONS ON THE PROBLEM OF DRUG USE AND DRUG ABUSE

COLIN BREWER



When I am in the mood for a little harmless and instructive amusement, I sometimes ask my alcoholic patients - having previously ascertained their usual daily consumption of alcohol and tobacco - "And do you use drugs?" The usual answer, and it is usually expressed with some vehemence, is to the effect that the patient most certainly does not take drugs, would never dream of doing so, and that drugs and those who use them are something close to the incarnation of evil. That kind of thing. Few patients seem aware of the irony or irrationality of their response. If I then put the obvious supplementary, "Do you not think that alcohol and tobacco are drugs?", some patents become a little angry while others, though sheepishly agreeing, indicate that they think the question rather unfair, which of course it isn't.

ONE MAN'S DRUG...

It actually goes to the root of attitudes to drug use in our society, where the characteristic sound of what passes for debate in most quarters is the sound of the users and pushers of conventional British recreational drugs deploring the habits and the users and pushers of slightly less conventional frugs with as little sense of irony as the most insightless of my patients. This is particularly true of the House of Commons whose licensing hours are by a considerable margin the most liberal in the country, whose members probably have rather more than their fair share of convictions for drunken driving and are sometimes manifestly under the influence of alcohol during debates on matters of national importance. This is not necessarily a bad thing, for alcohol can improve the flow of ideas as well as impair it. What is absurd, though highly symbolic of our irrational attitude to drugs, is the parliamentary convention that one may not accuse members either individually or in general of being drunk. Some MPs have so little sense of proportion - or contact with reality if you prefer - that when in a previous article I referred to this

state of affairs with almost oriental indirectness, I swear that the Honourable Members for Macclesfield and for Cheltenham - Mr. Nicholas Winterton and Mr. Charles Irving respectively - tried to have me dragged before the House, possibly in chains, for being in contempt of Parliament. Given that theirs was merely an extreme example of a common attitude, it is pointless to expect much in the way of sensible debate from our legislators. Let us try to do better in these pages.

A few inconvenient facts to begin with. Tobacco causes much more premature death and illness than all other drugs put together. The reply may correctly be made that at least tobacco doesn't cause people to go mad and beat their wives, as it were; but alcohol certainly does, and if by "drugs" are meant substances which affect the brain to an extent which can cause seriously unacceptable behaviour, then alcohol is far and away our most serious drug problem.

REAL VICTORIAN VALUES

In good Queen Victoria's golden days - which is how some members of the present Government apparently see them - official attitudes to drug-taking were relaxed to the point of invisibility. The Government's interest was almost entirely a fiscal one and, provided that the duty on dutiable drugs was paid promptly and in full, the great British public could get as drunk as it liked, and often did. There was a strong and quite effective temperance movement, but that was very much a private enterprise. Then as now, alcohol and tobacco were our main national drugs of us and abuse, but everything else could be had for the asking. When Marx referred to religion as the opium of the people, his metaphor was immediately understood because many people used opium. By no means all these users were addicted to it - in the sense of getting withdrawal symptoms if they discontinued it - because contrary to popular and, apparently, governmental belief, it is quite possible to use opiates, including heroin, on an occasional basis without developing physical dependence. Thomas de Quincey, author of Confessions of an English Opium Eater, use to take opium before taking a country walk or going to a concert. It is true that after about ten years of this accasional use he became physically addicted, but many of my alcoholic patients get physically addicted to alcohol in much less time than that. In any case, whatever harm opiates may do to one's social life, they are, unlike alcohol, without any lasting harmful effects on the organs of the body. Injection is naturally a more dangerous method of administration for any drug, but even injecting heroin causes no lasting physical damage provided that the heroin used is pure, and of known strength, and the equipment use to inject is is properly sterilised.

Apart from opium, Victorians with a taste for the unusual

could freely obtain almost as wide a range of drugs as is available today. Laughing gas was, after all, a product of early nineteenth-century technology, as was ether, and both of them were used for amusement - the Victorian equivalent of glue-sniffing - long before they were used for anaesthesia. They were the "designer drugs" of their day.

Like the present century, the nineteenth was one of exploration. The discovery and analysis of new plants meant in some cases the discovery of new drugs. Cocaine was one of these, as was marijuana. Both enjoyed a vogue in the last two or three decades of the nineteenth century and among those who testified to the virtues of Mariani's wine, which contained cocaine and was the Wincarnis of its day, was Queen Victoria herself. Another enthusiast was General - later President - Ulysses S. Grant, who is almost certainly not the only alcoholic to have reached the White House. Though not perhaps America's finest president, he gave us a few memorable phrases, including one which is very relevant to any discussion of illicit drug use: "I know of no method to secure the repeal of bad or obnoxious laws so effective as their stringent execution."

The end of the nineteenth century saw the modest epidemic of cocaine abuse but, like the earlier abuse of laughing gas and ether, the fad seems to have passed despite - or possible because of - the absence of the sort of screaming headlines which disfigure our newspapers today. Its disappearance was doubtless helped by legislation which made cocaine available only on prescription, but that merely put it in the same position as, say, Valium today. Few people seem to have stopped to consider why it was that most of the Indian inhabitants of the Andean states of South America use cocaine every day, and have done for hundreds of years, without much in the way of harm and indeed with considerable benefits. Similarly, those who insist that it is unreasonable to mention opium and alcohol in the same breath have to explain away the well-documented fact that even today, in several areas of South-East Asia, people smoke opium in the way that many people in Britain drink beer. That is to say that some do not use it at all, either because they disapprove of drug use or because they dislike the effects. Some use it occasionally. Many more use it regularly but in moderation. A few use it rather heavily and are undoubtedly physically addicted but manage to function quite well; while an even smaller number use it in a way which makes it difficult or impossible for them to carry out the necessary tasks of daily existence. Conversely, if alcohol is really such a harmless drug, how is it that it created so much social and physical havoc when it was introduced to societies such as the Polynesians and the North American Indians to whom it had previously been unfamiliar?

THE IMPORTANCE OF SOCIAL CONTEXT

Although it is an oversimplication to say that one should talk about addictive drugs, the truth is that the addictive potential of a drug is usually very much less important than the context in which it is used. How else do we explain the fact that many hundreds of thousands of people in Britain every year receive injections of drugs whose effects are almost identical with those of heroin before or after surgical operations, with virtually no cases of subsequent addiction? One often hears patients say after receiving their pre-medication that the effects were delightful and that they can well understand how people can get addicted to things like that, yet virtually the only people in hospitals who actually do become addicted to

such drugs are doctors and nurses, who are tempted to use them in a different context and for different reasons.

There are so many reasons for deploring the legislative hysteria about "drugs", but one of the more ironic is that, with or without "treatment"7, most opiate addicts seem to grow out of their addiction some time in their twenties or thirties. Some stop or greatly reduce their abuse of all drugs including alcohol. A few transfer their allegiance to other illicit drugs. Many become dependent on alcohol instead which may be legally less hazardous but medically more dangerous.

THE IDIOCY OF THE LAW

None of this is to deny that the abuse of drugs other than alcohol is a significant problem which damages many people and destroys a few, though far fewer than the numbers destroyed by alcohol, let alone tobacco. If the truly draconian penalties inflicted on the users and pushers of illicit drugs had led to a major reduction in their availability and use, it might be possible to justify present national - and international - policies despite the obvious libertarian objections. In reality, there is a growing consensus that these measures have made little impact and at the cost of sucking tens of thousands of people into a penal system which hardly even pretends to rehabilitate them. This is particularly deplorable because the evidence from the United States is that, although all methods of helping heroin addicts have a rather high failure rate, the best results - or at any rate the least bad - are obtained by programmes which operate within a legal framework. Virtually nothing of this kind exists in Britain, and indeed the Probation Service here contains a surprisingly large minority of people who feel that it is quite wrong to apply any sort of pressure to their clients even if they have entered into a legally binding agreement to do or not to do certain things. While it remains true that "you cannot train men for freedom in conditions of captivity", treatment as a condition of probation or imprisonment which deprives people of their liberty only at night or at weekends, combines a useful therapeutic potential for drugrelated offenders with minimal restriction of liberty. The British prison system is not merely brutalising, filthy, and over-crowded, it is also - and with only a few exceptions disastrously deficient in imagination and the willingness to experiment. Drunk or sober, it is the Members of Parliament responsible for the laws which send people to prison who bear a heavy moral responsibility for the conditions which exist there.

HYPOCRISY

The suspension of Ian Botham from first-class cricket for his admission that he had smoked marijuana is a splendid example of the hypocrisy which is at the very heart of the "drug problem". Several people have pointed out that he was suspended by a board which included at least two members who had been convicted of drunken driving - a type of behaviour considerably more dangerous to the health of the nation than the smoking of marijuana. While this lunatic dichotomy continues to dominate official thinking, it is useless to expect any improvement. Any country which gives honours and riches to the pushers and manufacturers of alcohol and tobacco while giving heavy prison sentences to the manufacturers, pushers and consumers of other drugs deserves all the problems it gets. Once again, Margaret Thatcher has got it right. We need to look more closely at some of those Victorian values.

> The last several years have seen an increase in racial incidents in our nation. Ironically, many of these have occurred in places known historically for being racially tolerant. Civil rights organizations have blamed the Reagan administration, but the blame for this reckless draining of our reservoir of ethnic goodwill lies elsewhere.

> Let's look at the pattern. When anti-black graffiti showed up at the University of Pennsylvania, the charges were that white racism and insensitivity were the culprits. However, when blacks murdered an Oriental student, or when they seek out white students to assault, intimidate, and rob, no similar charges of racism emerge.

For example: When black students, and a few whites, invited Black Muslim Minister Louis Farrakhan to address students, the University of Pennsylvania guaranteed his \$10,000 speaking fee and provided an auditorium. In response to questions about inviting Farrakhan to air his racial views on campus, the president's assistant hid behind the shield of "academic freedom" and free speech. Okay, I buy that.

But what if a group of students invited the grand dragon of the Ku Klux Klan or the head of the White Aryan Movement to speak? Do you think the university would have guaranteed the speaking fee and provided an auditorium?

Then there's Dartmouth College, which retains a black music professor who frequently uses the term "honky" in his classroom, yet he keeps his job. What if there was a white professor who used the word "nigger" in class? You can bet there'd be charges of racism and calls for his dismissal.

At Vassar College, a white student told a black student, during a heated exchange, that Marxism is for losers. The black student responded with racist barbs like "dirty Jews," "stupid Jews," and "f***ing Jews." The Vassar Spectator, the campus conservative student newspaper, planned to carry the story as its regular "Hypocrite of the Month" feature when the school ordered it not to run the issue.

The newspaper refused to abide by the order, so the college took away its funding and evicted the staff from its campus offices. No disciplinary action was taken against the black student, however.

Frustrated by these and other instances of uneven-handed treatment, some whites, who may never have been racists, are responding in ugly racist ways. Spineless, guilt-ridden do-gooders are creating a fertile recruiting ground for avowed racists.

racism. Some blacks have charged that "whites are racist by definition."

Then there was the Tawana Brawley hoax, wherein a young black woman alleged that she had been raped by a group of white men. The allegations were subsequently found to be baseless by a New York grand jury. There have also been cases where blacks have written racial graffiti and said it had been done by whites. One would think civil rights organizations would come down hard on these individuals, if not in the name of decency and fair play, at least in the name of the "Little Boy Who Cried Wolf."

After all, there is no better way to racially desensitize people than by way of hoaxes and empty charges of racism.

Decent, fair-minded Americans — black and white shouldn't sit around and watch our reservoir of racial goodwill demagoguery.


