## McBride Campaign Sets Vote Record

The McBride campaign set a new high water mark for Virginia Libertarian candidates going against both major parties.

Receiving nearly 20 percent of the vote, McBride topped by a large margin the previous mark of 15 percent set by Paul Gagnon in his 1991 race for Fairfax County Board of Supervisors. Although quite an accomplishment from an historical standpoint, it was not enough to claim victory in the race.

The Occoquan district seat of the Prince William County Board of Supervisors, vacated by the retiring Republican Ruth Griggs, was picked up by Republican Corey Stewart who defeated both McBride and Democrat Keith Scarborough. Stewart received 3,110 votes to Scarborough's 1,790 and McBride's 1,196.

Griggs surprised county Republicans last September when she withdrew her endorsement of Stewart, preferring instead to endorse Libertarian McBride.

In a letter to the Potomac News and Manassas Journal Messenger, Griggs called herself a "coward" for not endorsing McBride earlier. Saying that she had felt that

McBride was the better candidate all along, she had endorsed Stewart because she did not want to break with the Republican party.

"It took a lot of courage for Ruth to switch her endorsement," said McBride campaign manager Paul Miller. "To my knowledge, this type of endorsement is unprecedented in state party history. Ruth's courage showed that Robert was clearly the better candidate", he added.

McBride had also received the endorsement of the Northern Virginia Journal newspaper in October.

The campaign, one of the most exceptional in the history of the state party, was boosted by dozens of volunteers including forty who staffed the district's eight precincts on Tuesday. "I felt like the surfer dude with this great wave of energy pushing me along; all I had to do was keep my balance," said McBride to his volunteers at a post-election party Tuesday night.

Over the past several months, McBride and his volunteers were able to distribute campaign literature door-to-door to 23,000

## Libertarian Elected in Botetourt

Botetourt County Libertarian Jeff Bowles was elected Soil and Water Conservation District Director for the Mountain Castles District on November 4th. The final results were not released until November 6th.

Bowles decided to run a write-in campaign when he heard from the county registrar that there were two seats for director and only one declared candidate.

After discussing the idea with Jim Lark, who has been working closely with the new group, and Marc Montoni, who was elected as a Soil and Water Conservation District Director in the Lord Fairfax District in 2001, Bowles decided to seek the seat.

"At first it looked like very low-hanging fruit," explains

Bowles. "I thought I could ask my family, a few friends, and the members of our new affiliate to write me in, and that would be sufficient."

Things got a little more complicated when the local Republicans decided to run a write-in campaign with a very credible candidate as well. "We found out that we had a real race on our

hands the Wednesday before the election on Tuesday. At that point, I ordered some signs to put up at the entrances of the polls, and Liz (Bowles' wife) printed up 1,200 paper business-card-sized pieces with my name on them to give to voters at the polls. We sent

# 2004 Ballot Drive in Full Swing

On January 2, Libertarians in Virginia were permitted by state law to begin petitioning to place our candidates for President and Vice President on the Virginia general election ballot.

Successful petitioning means picking the time, days, and location carefully.

Location matters for most petitioning -- you want a high-traffic spot where you can ask large numbers of people.

Downtown malls are frequently excellent places to petition during lunchtime -- especially in spring and summer when workers take their lunch breaks outside. Plus, most downtown malls are public property -- which means the petitioner can petition without interference (which is not always the case when petitioning on private property).

Gun show visitors are also usually receptive to Libertarians -- many gun owners are now fully aware that only Libertarians stand with them at all times, and they are more willing to sign than many crowds.

Rock concerts at downtown stadiums are great for high numbers, but as most of the

patrons are young, many are unsure of their voting status and so the validity rate may be lower.

Two important dates stand out as excellent petitioning days -- the primaries for the May 4 and November 2 general elections. On February 10, the presidential primaries (if the Democrats and Republicans choose to select their candidates by primary, that is) will be held across the state. This primary will offer us an excellent chance to get nearly 100% valid signatures.

The LPVA will have plenty of blank petitions and other materials available for LP members interested in petitioning. For more information, contact the Petition Coordinator, Jim Lark, at PO Box 274, Free Union, VA 22940; call 434-973-5958; or email <JWLark@Virginia.edu>.

Incidentally, there will be various "rewards" programs offered by various LP members and perhaps even the state committee itself, for LPVA members who collect large numbers of signatures or who manage to collect certain numbers very rapidly.

So don't miss out -- get those petitions from Jim and hit the streets!

# State Central Committee meets in Fredericksburg

## October 18

The State Central Committee is the policymaking body of the LPVA.

Voting SCC members in attendance: Steve Damerell, Chair; Leonard Harris, Vice Chair; Kevin McKenna, Treasurer; Kevin Rollins, Proxy for Secretary; Stew Engel for the 1st Congressional District (CD); Tom Cantrell, CD2; David Hultstrom, CD3; James Curtis, CD5; Marc Montoni, CD6; George Marchenko, CD7; Dana Johansen, CD8; James Lark, CD9; Philip Hodson, CD10; Bill Lawry CD11. Non-Voting: Shaun Whelden, Communications Committee; Jim Turbett, Address Corrections Manager; Marianne Volpe, and one additional guest (name not captured).

At this meeting, the SCC:

- Considered (but did not adopt) an expulsion procedure.
- Approved a new contribution of \$3,000 from the General Fund to the McBride campaign; and added the provision that any leftover funds had to be returned to LPVA. On a roll call vote, all voted "Aye" except the 8th CD chairman, who abstained.

- Directed the Treasurer

to create a standing fund line called "Communications Committee"; and transferred \$ 500 to this fund from the General Fund. The funds are to be used for operating expenses authorized by the Chairman of the Communications Committee.

- Directed the Treasurer to create a standing fund line called "Political Development Committee" and transferred \$ 1,700 to this fund from the General Fund. The funds are to be used for operating expenses authorized by the Chairman of the Committee. The SCC also required that any revenue from the Campaign Committee's letters shall be returned to the General Fund.

- Authorized the Treasurer to move \$379.08 to the 2003 Special Convention fund from the General Fund, and thence to close out all accounting on the 2003 Special Convention.

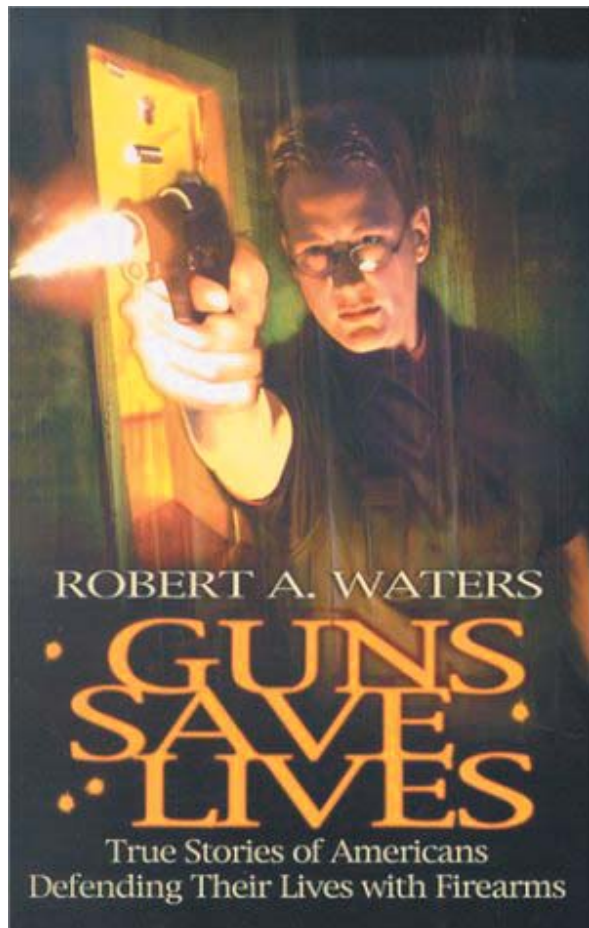
This is an excerpt from one of many stories contained in *Guns Save Lives: True Stories of Americans Defending Their Lives with Firearms*, by Robert

This book is an entertaining read. Each story is detailed, and well written. But you should buy this book for more than just the amusement it will provide; you should buy it as a tool to add to your toolbox in our struggle against the radical anti-gun fanatics.

# Affirmative Action Bake Sale Sparks Controversy

Williamsburg - November 24, 2003 - Libertarians at the College of William and Mary in Virginia have cooked up a controversy. Or rather, baked up a controversy.

An Affirmative Action Bake Sale conducted by the libertarian group Sons of Liberty was shut down by the administration on November 8.

Sons of Liberty members hosted the event in the University Center lobby, selling cookies and brownies at different prices for different racial and ethnic groups. For example, whites paid more than blacks or Hispanics.

Administration officials showed up at 3:00 pm, and told the libertarians they were in violation of the school's anti-discrimination policies. The group was ordered to sell the baked goods for the same price for everyone. Rather than comply, they closed up shop.

"The whole point was to show how affirmative action itself was racist," Sons of Liberty

cofounder William Coggin told the student newspaper, the Dog Street Journal. "The point of the stand was obvious."

Another Sons of Liberty cofounder, Pat Reilly, said he was surprised by the hubbub.

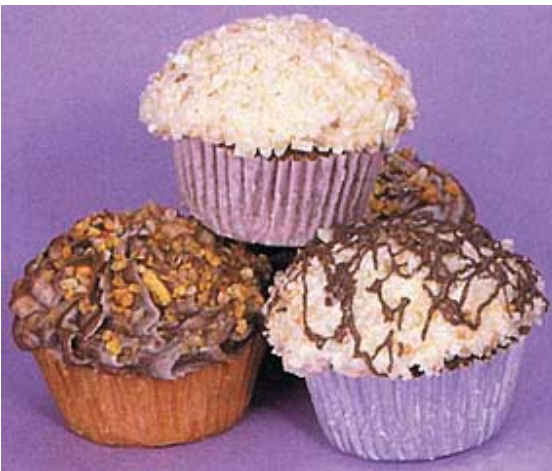
"I didn't think anyone would be offended by the price of a cookie," he said. "The point of the bake sale was just to raise awareness. It was not to offend anybody."

The bake sale put the "college community up in arms," according to the Dog Street Journal. The Student Assembly Senate even passed a resolution condemning the libertarians.

The College of William and Mary is located in Williamsburg. About 7,500 students attend the school.

Among Libertarians,

reactions were mixed. On the LPVA's public discussion email list (The Forum), Northern Virginia LP member Myron Pauli said that the university may not have been completely out of bounds. "The W&M students were



engaged in a 'commercial activity' - e.g. a 'bake sale' - which is not protected by the 1st Amendment," Pauli wrote.

Pauli thinks the Sons could have used a loophole to get around that: "If there was a bake sale where 'blacks' paid 50 cents and 'whites' paid \$1 (for example), it is non-discriminatory if they also

state that everyone has a right to declare himself/herself to be black, white, male, female, gay, straight, etc. regardless of race, creed, color, sex, etc. Then anyone who wants to pay the lower (or higher) price can just declare themselves to be a 'black lesbian Islamic communist transsexual from Mars'. The discrimination, in that case, is merely symbolic and then the University is punishing symbolic speech rather than a discriminatory commercial practice."

Others were disappointed by the conciliatory tone of the Sons. Jeff Pfeiffer of Shenandoah County noted a line in another article on the event, where sophomore Pat Reilly, co-founder of the Sons of Liberty and organizer of the bake sale, said "If they were offended, I'm honestly and deeply sorry."

Pfeiffer wrote, "Apologize to the real racists and bigots who support state sponsored racism? Affirmative Action is nothing [more than] state sponsored racism. Never apologize! ATTACK!"

out email to everyone we had addresses for in the county and attached a sheet of the handouts, asking them to copy them and hand them out, too."

Election day was a long one. Liz worked all day at the poll in Fincastle where the Bowles vote, while Jeff traveled to several other larger precincts. Their 19-year-old son, Brad, worked several hours at the polls and voted for the first time. "It was great to have a chance to vote and work for a Libertarian, who also happens to be my dad, in my first election."

It worked. Bowles won 233-202 over the Republican write-in candidate.

Bowles' wife, Liz, who is the coordinator of the new affiliate, believes that the success was due to the candidate and not particularly to the last-minute campaign.

"At the risk of sounding like the adoring wife, which of course I am, I have to say that Jeff is an ideal candidate. He has a long history of public and civic service. He is currently an EMT and volunteers with the local rescue squad. He was elected to the Town Council in Fincastle and was appointed to the Governor's Board on Migrant and Seasonal Farm

Workers. In the eighteen years that we have lived here, he has been President of the Chamber of Commerce, Master of the Catawba Masonic Lodge, a coach and the Roanoke Region Treasurer of Odyssey of the Mind/Destination Imagination, a soccer and Little League coach, an actor with Attic Productions (the local community theater group), a volunteer firefighter,

and a member of various committees for church and civic groups. He also worked at the local community bank, rising to the level of Senior VP/CFO before accepting a CFO position at a ski resort and then starting his own company. I grew up here, but Jeff knows everybody. All we had to do was let them know he was running and how to write him in."

# Take our children off the Drug War battlefield

Police pointing guns at children as they lay face down on the floor is what we expect to see in propaganda films about the Gestapo of WWII, not in the halls of our own high schools. I'm glad that former congressman Bob Barr finds this image "deeply disturbing" [Creative Loafing, Nov 20, '03]. But Mr. Barr still does not seem to realize that it was his drug prohibitionist zealotry while in the US House that has led inexorably to such horrifying incidents as the Nov. 5 drug raid on Stratford High School in Goose Creek, S.C.

Barr decries the raid on students as an "overreaction." Yet he was Congress' most ardent drug warrior and its chief proponent of sending armies of armed agents to raid medical marijuana clinics in California. The clinics, legal under state law, were the victims of the same SWAT team tactics as seen at Stratford High School. In one raid on a hospice, police pointed weapons at an elderly invalid, shouting at her to get out of bed with her hands up, while she vainly tried to

explain her paraplegia would not allow her to do so.

Where is the dividing line between a drug raid on the sick and dying, which Congressman Barr stridently supported, and a drug raid on equally terrified students, which Mr. Barr condemns?

Barr, to his credit, does seem to recognize that there are excesses in the drug war. But condemning excesses in the drug war is like condemning the excesses of slavery. The problem 200 years ago was not that we had too many slaves, but that slavery itself was wrong.

Prohibition itself is also wrong. Abraham Lincoln said, "Prohibition goes beyond the bounds of reason in that it attempts to control a man's appetite by legislation and makes crimes out of things that are not crimes. A prohibition law strikes a blow at the very principles upon which our government was founded."

We all learned in high school about the effects on society of the "noble experiment" of alcohol prohibition: the rise of organized crime, drive-by shootings, corruption of the courts, payoffs to police who could not resist the lure of easy

money, and assassination of those who could. Despite the law, alcohol consumption did not decrease. It merely shifted from beer and wine to easier to smuggle hard liquor and the contaminated bathtub gin that blinded thousands.

Our current politicians, and Mr. Barr while in Congress, seem blinded to the obvious fact that we have all the same problems again, thanks to the new prohibition of the War on Drugs. Perhaps Mr. Barr's new softer, saner stance is due to his having more time to reflect since leaving office. Or perhaps he realizes he lost his primary bid, in part at least, due to the Libertarian Party's advertising campaign pointing out his extremist views on medical marijuana.

We can hope that Mr. Barr will come to recognize the role he played in creating the societal attitudes that could allow the Goose Creek raid to happen. And we can hope he will continue to move toward the more rational drug policies that will make our streets safer from gang violence and our high schools safer from police violence.

For there are really only two directions for drug policy.

We can have prohibition, and the violent, uncontrolled black market that inevitably results. We can continue to arrest the terminally ill just for trying to alleviate their pain. And we can terrorize more students with raids.

Or, much like alcohol, we can have the controlled regulation that is inherent in the free market. It's not a perfect solution. But just as with the repeal of alcohol prohibition, it recognizes the reality that the consequences to society from drug prohibition are even worse than from drug use itself.

As a Libertarian, I believe in legalization and a move to free markets instead of black markets as the best way to ameliorate our drug problems. But while we have a war on drugs, what sense does it make to target the least powerful among us? Can't we at least take our children and students, and the sick and dying off the battlefield?

# Who Paid the Baker's Taxes?

It certainly wasn't the baker, but then nobody directly pays their own taxes anyway. Our entire scheme of Federal, State and Local income taxes and payroll (FICA) taxes exists solely to conceal from the voter the truth about who really pays the taxes. So, who pays the baker's taxes?

Well, where does the loaf of bread he sells come from? A farmer grew and harvested wheat for sale to the miller. The farmer paid income taxes based on his profit from the sale and property tax on his farm and equipment. Those taxes were, from his point of view, just another cost of doing business in the course of earning his living, just like fuel for his tractor or wages for employees. Since every other farmer had roughly the same expenses and taxes, the price they charge the miller must cover their expenses and taxes, plus their actual

disposable income. Otherwise, there would be no point in growing wheat. All of these costs and taxes were passed on to the miller, hidden in the price of wheat.

Likewise, when the miller sold the flour ground from the wheat to the baker, his taxes, plus the income and FICA taxes he withheld from his employees, plus the farmer's taxes, were all passed on to the baker. The baker then sells his bread made from the flour, carrying with it his own taxes plus those of his employees, plus all those previous hidden taxes from the farmer, miller and their employees, hidden in the price of that loaf of bread. The buyer and his family eat the bread, and, having done so, cannot sell it to anyone else and pass the taxes along, as the baker and everyone else before had done.

So, it is the consumer who paid the baker's taxes, along with the farmer's taxes, the miller's taxes and the taxes

they withheld from all of their employees. From bread to automobiles to brain surgery, the price of everything we buy carries in it the hidden taxes of everyone who contributed to the production of that product or service to the tune of, on average, forty cents out of every dollar we spend. Our entire complex, pervasive and expensive tax code is, in reality, a scheme to draft businesses and individuals as unpaid and unknowing tax collectors to gather a hidden sales tax, mostly from the middle class, and to keep the voters from realizing who really pays those high taxes.

There is no way around this central reality that all income and business taxes are a deception and that all taxes are eventually paid by the consumer, hidden in the price of goods and services. It doesn't matter what tax rate is applied to which tax bracket, or what deductions you receive. These devices only change the degree

to which you are a tax collector, but the tax you ultimately pay depends solely on what you spend.

Paying this consumption tax is unavoidable, but the illusion of income based taxing does a great deal of harm. First, it distorts our economic decisions. Goods and services that are labor intensive, like automobiles and health care, are artificially more expensive than necessary, while raw materials and natural resources are under priced, leading to over consumption and waste. But even worse, hidden taxes distort the political process, encouraging government overspending by politicians who exploit the mistaken belief of many voters that government spending can be paid for solely by taxing corporations or the "rich." Voters might well choose differently were they aware that government spending is ultimately paid for by everyone, through an invisible sales tax.
