Amend 2.13 Healthcare Plank as follows:

We acknowledge that individuals have a right to obtain health care; as the right to bear arms does not dictate the government needs to purchase guns for all Americans, the individual right to health care does not necessitate the state provide health insurance for all. We favor a free market health care system. We recognize the freedom of individuals to determine the level of health insurance they want (if any), the level of health care they want, the care providers they want, the medicines and treatments they will use and all other aspects of their medical care, including end-of-life decisions. People should be free to purchase health insurance across state lines. (Gilson, Knapp, Martin, Perry - 30 minutes)

We support the right to self defense and applaud those who sacrifice their time, money, armaments and lives to defend the Americans' freedoms from attack. The United States should both avoid entangling alliances and abandon its attempts to act as policeman for the world. We oppose any form of compulsory national service. (Ebke, Gilson, Martin, Roots)

Substitute:

We support the maintenance of a sufficient military to defend the United States against right to self-defense against any forces that initiate aggression. The United States should both avoid entangling alliances and abandon

its attempts to act as policeman for the world. We oppose any form of compulsory national service. (Cholko, Knapp, Martin, Meckley)
